

**TOWNSHIP OF CHESTERFIELD
ORDINANCE 2015-15**

**AN ORDINANCE AMENDING CHAPTER 182 “VEHICLES AND TRAFFIC”
OF THE CHESTERFIELD TOWNSHIP CODE FOR LOWERING
THE SPEED LIMITS ON PORTIONS OF
CROSSWICKS-ELLISDALE ROAD**

WHEREAS, pursuant to N.J.S.A. 39:4-8, the Township Committee of the township of Chesterfield has the authority to regulate the speed limit of those streets under the Township’s jurisdiction; and

WHEREAS, the Township Committee, in the interest of safety, has determined to lower the speed limit along portions of Crosswicks-Ellisdale Road, in both directions; and

WHEREAS, the Township Engineer, in accordance with N.J.S.A. 39:4-8(b), has investigated the circumstances and finds they meet the criteria of the 25, 35 and 45 miles per hour status speed limit and in the interest of safety to reduce the speed limit to 25 and 35 miles per hour, along portions of Crosswicks-Ellisdale Road, pursuant to the engineer’s Certification dated October 21, 2015, attached hereto and made a part hereof.

BE IT ORDAINED by the Township Committee of the Township of Chesterfield, County of Burlington, State of New Jersey, that the Township Code be amended as follows:

SECTION ONE: §182-21 Schedule II: Speed Limits be and is hereby amended to including the following:

<u>Street or Road</u>	<u>Speed Limit</u>	<u>Location</u>
Crosswicks-Ellisdale Road	25 MPH	From the intersection of Chesterfield-Crosswicks Road, to a point easterly 500 feet
Crosswicks-Ellisdale Road	35 MPH	From a point 500 feet easterly from Chesterfield-Crosswicks Road for a distance approximately 3000 feet
Crosswicks-Ellisdale Road	45 MPH	From a point 3500 feet easterly from Chesterfield-Crosswicks Road to the Chesterfield-North Hanover Township Line

BE IT FURTHER ORDAINED that all signs which list the speed limit on Crosswicks-Ellisdale Road to the contrary of the above be removed, and signs posting the speed limits of 25, 35 and 45 miles per hour be posted.

SECTION TWO: All Ordinances and provisions thereof inconsistent with the provisions of this Ordinance shall be and are hereby repealed to the extent of such inconsistency.

SECTION THREE: If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.

SECTION FOUR: This ordinance shall take effect immediately upon final passage and publication according to law.
