ORDINANCE NO. 2016 - 9

AN ORDINANCE AMENDING ORDINANCE NO. 2016-2 TO ESTABLISH A FOUR (4) TON WEIGHT LIMIT ON ADDITIONAL STREETS WITHIN THE TOWNSHIP OF CHESTERFIELD

WHEREAS, the Township Committee unanimously adopted Ordinance No. 2016-2, incorporated by reference herein, during a public meeting on February 26, 2016, after the same was introduced during a public meeting on February 11, 2016; and

WHEREAS, Ordinance No. 2016-2 amended and supplemented portions of Chapter 182 of the Code of the Township of Chesterfield, “Vehicles and Traffic;” and

WHEREAS, the Township Committee has determined that additional municipally owned and maintained streets exist within the Township which were inadvertently overlooked and not listed in Ordinance No. 2016-2.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Chesterfield, County of Burlington, State of New Jersey, that Ordinance No. 2016-2 is amended and supplemented as follows, with all other recitals and provisions to remain the same (additions are underlined):

ARTICLE I: Section 182-25 Schedule VI: Trucks Over Certain Weights Excluded is hereby established as follows:

In accordance with the provisions of §182-9, vehicles having a total combined gross weight equal to or in excess of four (4) tons (weight of vehicle plus weight of load), are excluded from traveling on the following municipally owned and maintained streets and roadways:

ARTICLE II: REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
