

TOWNSHIP OF CHESTERFIELD

ORDINANCE NO. 2017-9

AN ORDINANCE TO AMEND CHAPTER 182-21, ALSO KNOWN AS “SCHEDULE II: SPEED LIMITS” OF THE CODE OF THE TOWNSHIP OF CHESTERFIELD TO ESTABLISH NEW SPEED LIMITS ON WHITE PINE ROAD

WHEREAS, the Township Committee has requested an investigation of the appropriate speed limit for a portion of White Pine Road, which portion lies between the Chesterfield Township/Mansfield Township boundary line, and Bordentown-Georgetown Road (CR 545); and

WHEREAS, White Pine Road is a Township roadway and it is therefore permissible for Chesterfield Township to establish an appropriate speed limit in accordance with the provisions of N.J.S.A. 39:4-8; and

WHEREAS, the Township Engineer has certified that, based on current AASHTO Design Standards, a reasonable speed limit based upon engineering and traffic concerns, is 40 miles per hour for this section of White Pine Road.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Chesterfield, County of Burlington and State of New Jersey that Section 182-21 be and the same is hereby amended to recognize the speed limit on White Pine Road as follows:

NAME OF STREET	SPEED LIMIT (MPH)	LOCATION
White Pine Road	40	Between Bordentown-Georgetown Road (CR-545) and Chesterfield-Georgetown Road

BE IT FURTHER ORDAINED AND ENACTED that this Ordinance shall take effect upon proper passage in accordance with the law and upon filing of this Ordinance, as

well as the Engineer's certification and the Engineer's cover letter of June 21, 2017 to the Commissioner of the Department of Transportation in accordance with the provisions of N.J.S.A. 39:4-8(b).

REPEALER, SEVERABILITY AND EFFECTIVE DATE.

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
