

**TOWNSHIP OF CHESTERFIELD**

**ORDINANCE 2017-07**

**AN ORDINANCE AUTHORIZING THE ESTABLISHMENT OF  
A RECREATION DIRECTOR**

**WHEREAS**, over the last few years, the Township of Chesterfield has offered more and more recreational opportunities and amenities to the youth of this community, and the Township Committee, working with the Chesterfield Township Athletic Association (“CTAA”), has embarked upon improvements to fields, development of structures and other improvements to sports and recreational fields; and

**WHEREAS**, the Township Committee has determined that it would be beneficial to the community to create the position of Recreation Director to manage the various recreational programs within the community; and

**WHEREAS**, the Township Committee prefers to afford flexibility in the duties and operation of said Recreation Director, but nevertheless wishes to establish same by way of an Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** that the Township Committee of the Township of Chesterfield, County of Burlington, State of New Jersey as follows:

**Article I. Recreation Director Established.** There is hereby created the position of Recreation Director for the Township of Chesterfield. The Recreation Director shall be appointed annually by the Township Committee and shall be compensated in accordance with the Township’s annual Salary Ordinance. It shall be the duty and responsibility of the Recreation Director to entertain requests for the utilization of municipal recreation fields, and to coordinate the use of said fields by and between the various recreation organizations, non-profit groups, schools, and other associations wishing to use municipal parks, fields and

recreational opportunities. The Recreation Director shall not only maintain a schedule of the use of all fields, parks and playgrounds, but shall also ensure that any and all fees required to be paid for using same are properly deposited with the Township prior to usage. In the event that the governing body determines the need for an agreement by and between the Township and the users of said fields, the Recreation Director shall ensure that said fees are paid and said agreements are executed prior to utilization of the fields by said group(s). Finally, the Recreation Director shall assist community organizations with the scheduling of fields, parks and playgrounds; and undertake such other duties as may, from time to time, be assigned by the Township Committee.

**Article II. REPEALER, SEVERABILITY AND EFFECTIVE DATE.**

- A. Repealer. Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
