STATE OF NJ FIREARMS PURCHASER IDENTIFICATION CARD

ORIGINAL – For Rifle or Shotgun. Also necessary for a PERMIT TO PURCHASE HANDGUN.

DUPLICATE – If your card is lost, mutilated or stolen and originally issued in Chesterfield Twp.

For a change of address, name, etc., from another issuing authority, if you now reside in Chesterfield Twp.

You must be 18 years old to apply.

PERMIT TO PURCHASE HANDGUN

This may or may not be requested by you with the application for Original Firearm ID Card. You must be 21 years of age to apply. If you wish a Permit to Purchase and you already have a valid NJ Firearms Purchaser Identification Card, you will only need a Request for Criminal History form (yellow sheet).

NOTE: Permits to Purchase are valid for **90** days from the date of issue. This permit can be extended for only **ONE** additional 90-day period. Please do not ask us to extend beyond that, we cannot without doing a Criminal History form again.

INSTRUCTIONS

1. You must be a resident of Chesterfield Township to apply.
2. Fill out all paperwork **COMPLETELY** and **PRINT LEGIBLY**.
3. Be sure that the address that you put on these forms match your NJ drivers license address exactly.
 - a. Be sure that **ALL** blocks are completed. Place N/A in the blocks where questions do not apply to you.
 - b. Answer all questions with **YES** or **NO**. Do not circle answers.
 - c. Make sure you sign all forms where necessary.
 - d. You must supply two people that will be a reference for you. Please supply complete name, home mailing address (including zip code) and home telephone number.
 - e. Supply your place of employment and telephone number.
4. You must make an appointment with SAFRAN (by MorphoTrust) for fingerprinting. When you have the completed the forms, please contact Aggie (609) 291-0912 to pick up the form that needs to be taken with you to process the fingerprinting, you will be given instructions on how to make the appointment at that time.

5. If you already have a valid SBI number and you only need a Request for Criminal History, Please see APPLICANT INSTRUCTIONS form.
6. Please be aware that if you are changing your address on your Purchase Identification card, I will be sending a letter to the Original Issuing Authority to have all previous paperwork sent to our office.
7. You will be contacted as soon as the results come back to this office and we will set up a date and time to finish your paperwork.
